| <b>DEFENDANT'S BILL OF COSTS</b>   |   |

Defendant Ronald Pace, through his undersigned counsel, submits his Bill of Costs pursuant to C.R.C.C.P. 354 (d); C.R.C.P. Rule 121 § 1-22; C.R.S. §§15-16-105, 13-16-122 (1); 13-33-102; and 13-33-103.

1. On November 9, 2009, of this Court entered an Order dismissing Plaintiffs' Verified Complaint/Motion for Civil Protection Order with prejudice, in its entirety. In the absence of a deadline under the Colorado Rules of County Court Civil Procedure, Defendant assumes that the 15-day deadline applicable under C.R.C.P. Rule 121 § 1-22 will apply.

2. Rule 354(d) of the Colorado Rules of County Court Civil Procedure requires the Court to award reasonable costs to a prevailing party. The rule provides, in pertinent part:

(d) Costs. Except when express provision therefor is made either in a statute of this state or in these rules, costs shall be allowed as of course to the prevailing party unless the court otherwise directs; but costs against the state of Colorado, its officers or agencies, shall be imposed only to the extent permitted by law. Costs may be taxed by the clerk on one day's notice.

*See also* C.R.S. § 13-16-105 (“If any person sues in any court of record in the state in any action wherein the plaintiff or demandant might have costs in case judgment is given for him and he is nonprosessed, suffers a discontinuance, is nonsuited after appearance of the defendant, or a verdict is passed against him, then the defendant shall have judgment to recover his costs against the plaintiff”).

3. The prohibition against the allowance of costs against the state of Colorado, its officers or agencies does not extend to local governments. *Kussman v. Denver*, 671 P.2d 1000, 1002 (Colo. App. 1983) (costs may be recovered against municipal corporations).

4. Section 13-16-122 (1) provides a list of recoverable costs which may be awarded by the Court. A list of expenses that may be awarded as costs under 13-16-122, however, is illustrative and not exclusive. *Cherry Creek School District #5 v. Voelker*, 859 P.2d 805, 813 (1993), *citing Ferrell v. Glenwood Brokers, Ltd.*, 848 P.2d 936, 940 (Colo. 1993). In general, absent a specific prohibition, the trial court has discretion over the awarding of costs. *Id.*

5. Pursuant to the foregoing authority, and additional authority cited below, Defendant respectfully requests the Court to enter judgment in favor of Defendant and against Plaintiffs for reasonable and actual costs as set forth in the Bill of Costs. Where available, bills and invoices are attached.
